This Fighter Wing Instruction (FWI) implements AFPD 21-1, *Managing Aerospace Equipment Maintenance*. It applies to all 926th Logistics Group (LG), 926th Maintenance Squadron (MXS), and 706th Flying Squadron Maintenance (FSM) personnel.

SUMMARY OF REVISIONS

This revision establishes critical levels of aerospace ground equipment (AGE), munitions handling equipment and delivery vehicles required to meet designed operational capability (DOC).

1. Responsibilities . The LG Commander, MXS Superintendent, AGE Flight Supervisor, Munitions Storage/Missile Maintenance (LGMWA) Supervisor, and FSM Superintendent ensure compliance with this FWI.

2. Procedures:

2.1. The following list of AGE is considered mission essential:

2.2. The AGE supervisor collects AGE status from LGMWA and submits the status to Maintenance Control Operations (CPM) each workday on AF 2431, **Aerospace Ground Equipment Status Log**.

2.3. CPM coordinates plans with appropriate supervisors to preclude a further decline of in commission status of above equipment. Plans are thorough and extensive and all avenues of action are explored to prevent a decline in serviceability of equipment. All available resources are investigated; i.e., cannibalization, overtime, contract maintenance, etc.

2.4. CPM monitor location of equipment if the in-commission level falls below the minimum requirements.
