

# AIR FORCE INSPECTOR GENERAL (IG) COMPLAINT PROGRAM

1. You can get help quickly and fairly under the Air Force IG complaint program, and you can make your complaint at any level in the IG system without fear of reprisal.
2. Some matters are not covered under the IG program. These are matters which are covered under another governing directive. The following table shows certain types of complaints which are not covered under the IG program and list the reference directive or agency:
